ADVISORY NOTICE WITH REFERENCE TO ARTICLE 13 OF EU REGULATION 2016/679 FOR THE PURPOSES OF THE COMPETITION ANNOUNCEMENT OF THE CLAUDIO SCIMONE INTERNATIONAL AWARD SECOND EDITION 2020

Dear Sir or Madam,

According to EU Regulation 2016/679 on protection of individuals with regard to the processing of personal data, the Rotary Club Padova in the person of its legal representative, as the holder of the processing of your personal data, informs you of the following:

1. Data controller

The data controller is Rotary Club Padova, in the person of its President, Massimo Pegoraro, with its headquarters in Padova, Via San Biagio, 34; email padova@rotary2060.org, certified email rotarypadova@pec.it.

2. Purpose of data processing

Your personal data will be processed for the following purposes:

- a) implementation of tasks related to the COMPETITION ANNOUNCEMENT OF THE CLAUDIO SCIMONE INTERNATIONAL AWARD SECOND EDITION 2020;
- b) sending communications by e-mail or mobile phone necessary for the completion of the tasks and purposes referred to in point a);
- c) purposes related or instrumental to compliance with obligations under the Club Statutes and Regulations, laws, regulations, or community rules, or by provisions issued by State authorities.

3. Legal basis of data processing

The data processing for the purposes referred to in points a) and b) in paragraph 2 is based on your consent and is mandatory as it is necessary in order to deal with your application. If you do not give your consent, we will not be able to process your application and thus cannot include you in the selection process.

The data processing referred to in point c) in paragraph 2 is based on the need to fulfil legal obligations which the data controllers are subject to.

4. Recipient Categories

Your data, to complete the purposes referred to in point 2, may be communicated to other Rotarian Members or to the staff authorized to carry out the selection operations as members of the Jury, or to the consultants who deal with the Statutory and Regulatory tax matters of the Rotary Club Padova.



5. Holding period

Your personal data will be retained only for the time required to achieve the objectives described in point 2, or until expressed intention to withdraw is given, as referred to in point 8 (below).

Any data which is not required for the Club to comply with a legal obligation or regulation will be deleted at the end of the selection process.

6. Rights of the interested party

As the interested party, you have the right to ask the controller for access to your personal data, to rectify or delete it, to restrict processing, or to object to processing in the foreseen cases. You also have the right to ask for the transferal of your data.

7. Withdrawal of the consent

Regarding cases in which the data processing is based on consent (as described in paragraph 2 points a) and b)), you may at any time withdraw the consent that has been given, without affecting the legality of the data processing carried out before said withdrawal.

If consent is withdrawn, data processing will no longer be allowed and withdrawal will mean that it will be impossible to proceed with the examination of the candidate's application.

8. Right to complain

If your personal data is mishandled, you may file a complaint with a supervising authority (in Italy, the Personal Data Protection Authority) or in any case to the Ordinary Judicial Authority.

9. Consent requirement

Consent for the purposes referred to in points a) and b) is mandatory in order to process your application and carry out the selection proceedings. If you refuse to give the necessary consent, your application cannot be taken into consideration.
